## **SCHEDULE C WASTE MANAGEMENT CHARGES**

1. The following waste management charges shall be levied on a flat rate basis per user:
  - a) Residential garbage collection, disposal & recycling \$120.00 per dwelling unit.
  - b) If more than one dwelling unit is located at a property address, the charge shall be determined using the following formula:  
  
\$120.00 x number of dwelling units per property address.
  - c) Commercial units successfully granted the right to Collection Services by the County of Simcoe shall be levied a waste management charge of \$120.00 per unit.
  - d) All other Commercial units shall be levied a recycling charge of \$33.00 per unit.
2. Waste management charges shall be added to the annual tax levy of each applicable property and be due and payable in the same manner and at the same time as the final tax bill.
3. Interest and penalty charges shall be applied in the same manner and at the same time as applicable to non-payment of installments of the tax bill.



## SCHEDULE D OVERNIGHT CAMPING FEE

1. The following overnight camping fee shall be charged per user:
  - a) Overnight Camping Fee: \$30.00 per recreational vehicle<sup>1</sup> per night.

<sup>1</sup> A 'Recreational Vehicle' is defined as a vehicle such as a travel trailer, tent trailer, camper van, or motor home used for traveling and recreational activities.
