

**BY-LAW No. 2010-076
OF THE
CORPORATION OF THE TOWN OF COLLINGWOOD**



BEING A BY-LAW TO DESIGNATE PARTS OF A HIGHWAY AS
COMMUNITY SAFETY ZONES

WHEREAS pursuant to Section 214.1(1) of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, as amended, the council of a municipality may by by-law designate a part of a highways under its jurisdiction as a community safety zone, if in the opinion of Council, public safety is of special concern on that part of the highway;

AND WHEREAS Council of the Town of Collingwood passed By-law No. 00-62, designating certain highways throughout the municipality as Community Safety Zones;

AND WHEREAS Council deems it necessary to amend By-law No. 00-62;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF COLLINGWOOD ENACTS AS FOLLOWS:

1. **THAT** Schedule A of By-law No. 00-62 be amended to add the following portions of a highway as a designated Community Safety Zone:

Column 1 <i>Designated Highway Name</i>	Column 2 <i>Between</i>	Column 3 <i>Time Period in Effect</i>
17) Oak Street	North of First Street to Cedar Street	Anytime January 01 through December 31
18) Cedar Street	North of First Street to Oak Street	Anytime January 01 through December 31
19) Lockhart Road	Between Katherine Street and Carmichael Street	Anytime January 01 through December 31
20) Paterson Street	Between Hume Street and Lorne Street	Anytime January 01 through December 31
21) Lorne Street	Between Alice Street and Paterson Street	Anytime January 01 through December 31
22) Erie Street	Between Niagara Street and Raglan Street	Anytime January 01 through December 31
23) Ontario Street	Between Niagara Street and Pretty River Parkway	Anytime January 01 through December 31

2. **THAT** number 13 of Schedule A of By-law No. 00-62 be deleted and replaced with the following as a designated Community Safety Zone:

Column 1 <i>Designated Highway Name</i>	Column 2 <i>Between</i>	Column 3 <i>Time Period in Effect</i>
13) Findlay Drive	Between Hurontario Street and High Street	Anytime January 01 through December 31

3. **THAT** this By-law shall come into full force and effect on the date of final passage hereof at which time all By-laws and/or resolutions that are inconsistent with the provisions of this By-law and the same are hereby repealed or rescinded insofar as it is necessary to give effect to the provisions of this By-law.
