

BY-LAW No. 2022-082
OF THE
CORPORATION OF THE TOWN OF COLLINGWOOD



Being a by-law to amend delegation of authority by-law no.2020-59 for the town of Collingwood.

WHEREAS the Municipal Act 2001, S.O. 2001, c 25, Section 270(1), provides that a municipality shall adopt and maintain policies with respect to the delegation of its powers and duties;

AND WHEREAS the Municipal Act 2001, S.O. 2001, c 25, Section 5(3), provides a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS Council of the Town of Collingwood is directly accountable to constituents for legislative decision making fortified by by-laws and resolutions and through Town Officers and Employees, the administration of policies, procedures and operations;

AND WHEREAS Council herein entrust specific Officers and Employees of the Corporation with certain delegated powers and duties necessary to carry out administrative and operational functions within their purview;

AND WHEREAS Council has enacted By-law No. 2020-059, a by-law to delegate certain powers and duties to Officers and Employees of the Corporation of the Town of Collingwood;

NOW THEREFORE THE COUNCIL OF THE TOWN OF COLLINGWOOD HEREBY ENACTS AS FOLLOWS:

1.THAT the following delegated powers and duties in Schedule "A" of By-law No. 2020-059, as amended, are hereby amended by adding the words. "or their designate" following each listed delegate(s):

Authority	Delegate	Criteria/Condition
Consider and approve or refuse to approve site plans and drawings	Director of Planning, Building and Economic Development or their designate	The authority to consider and approve or refuse to approve site plans and drawings pursuant to Section 41(4) of the Planning Act, R.S.O. 1990, c. P.1 3, as amended, including the power and authority to require the owners of land to enter into site plan agreements or undertakings with the Town of Collingwood as a condition to the granting of such approvals to the satisfaction of the Town Solicitor and the authority to execute such agreements for all applications received after July 1, 2022

Authority	Delegate	Criteria/Condition
Give effect to approval of site plans and drawings	Director of Planning, Building and Economic Development or their designate	Do all things necessary, including, but not limited to, the authority to amend, adjust or release any registered agreement or undertaking, to give effect to approval of plans and drawings for a development under Section 41 (4) of the Planning Act, R.S.O. 1990, c. P. 1-3, as amended.

2.THAT this by-law shall come into full force and effect on the date of final passage hereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.
