Birks Natural Heritage Consultants Inc. (Birks NHC) was retained to undertake the completion of an Environmental Impact Study (EIS) for the proposed development of a property located at the 11589 Highway 26 in the Town of Collingwood. Through completion of the study, Birks NHC identified wetland habitats within and adjacent to the property limits: a unit of the Silver Creek Provincially Significant Wetland (SWDM2-2) and an unevaluated deciduous swamp (SWDM4-1) which have been illustrated in Figure 2 of the EIS (Birks NHC, 2021) provided as attached. It is our understanding that the SWDM2-2 unit will be retained, and protected during the development through implementation of a 30 m naturalized setback. The SWDM4-1 is proposed for removal to permit the construction of the dwellings and road access.

Comments received by email (September 3, 2022) from Nottawasaga Valley Conservation Authority (NVCA) request the completion of a Wetland Offsetting Plan as part of the complete submission. These comments have been copied here for ease of review:



Natural Heritage and Ecology - Advisory Comments

- 4. The 0.16ha SWDM4-1 wetland is proposed to be removed to accommodate the proposed development. The applicant will be required to demonstrate consistency with NVCA's board-approved Ecological Net Gains Guidelines with regards to the proposed offsetting methods to compensate for the removal of this feature.
- 5. NVCA staff will require submission of a satisfactory Wetland Offsetting Plan as part of a complete submission for any approval under the Planning Act. This requirement may not be deferred to detailed design or site plan conditions.

The Nottawasaga Valley Conservation Authority (NVCA) has prepared a document "Achieving Net Gains Through Ecological Offsetting" (September 2021) which is the vehicle by which the SWDM4-1 is proposed for removal, following the cash-in-lieu option for offsetting.

The wetland unit was delineated in July 2022 by Birks NHC staff using protocols outlined in the Ontario Wetland Evaluation System Manual – Southern Manual, 3rd Edition, Version 3.2 (MNRF, 2013) and was surveyed in October 2022 by Tatham and Associates (Figure 4 attached). After survey, the total area of the wetland unit was calculated to be 0.16 ha. A 30 metre setback to this limit has been applied, and the area of the setback calculated to be 0.32 ha. Thus, the Total Area of Loss for this scenario would be:

$$(0.16 \text{ ha x 2}) + (0.32 \text{ ha x 1}) = 0.64 \text{ ha}$$

The cash-in-lieu replacement fee for wetland habitats has been determined by the NVCA to be \$120,000.00 per hectare. Thus, the total cost to offset the removal of the SWDM4-1 wetland unit is:

Thus, we propose remuneration of \$76,800.00 to the NVCA for the for the permanent alteration of the SWDM4-1 wetland unit. Arrangements for remuneration should be directed to NVCA at the time of resubmission.


