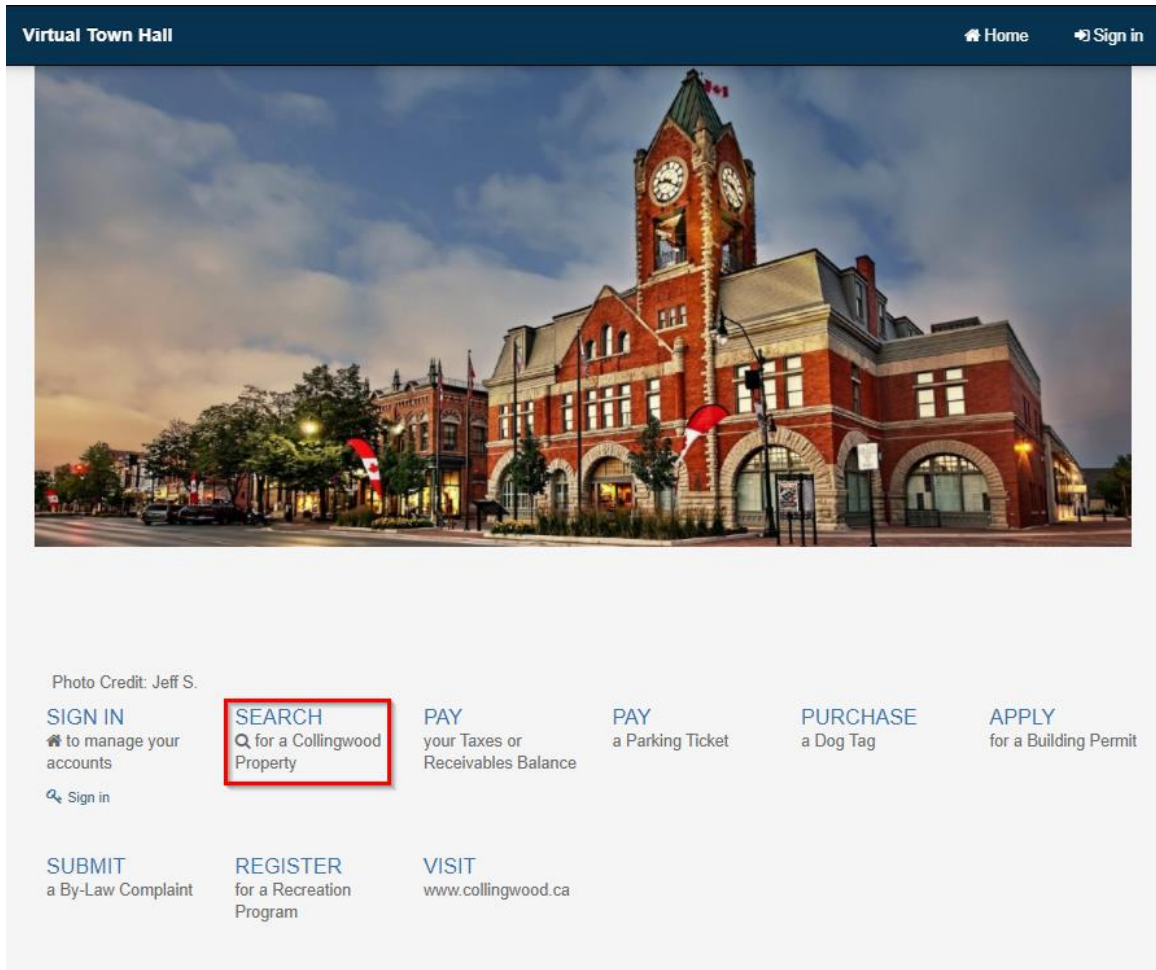


# How to Complete a Property Search in Virtual Town Hall
